

Thank you for purchasing this Jupio \*ProLine\* Extreme V-Mount battery. Please read these instructions carefully before using this product, and save this manual for future use.

### Operating Instruction Charge

Charge time may vary depending on different conditions and charger used. Operating temperature range of 0°C~40°C. For optimum charging performance 10°C~30°C is recommended. If the temperature of the battery is below 0°C, the battery will not fully charge even if designated charge time has lapsed. The battery must be charged within the recommended temperature range.

#### **Discharge**

Maximum continuous discharge current is 10A (Note: When using the battery with video or lighting equipment power consumption of te equipment must be 10A or below. For the protection of the battery, a load of 6.0A or over may activate the internal protection circuit and terminate the supply of power.) The operating voltage range of this battery is 13V~16V. At the end of discharge and when its voltage reached 13V and beyond, the voltage will drop sharply. (For battery voltage alarm setting, please refer to camera manual)


#### **Storage**

- Storage temperature range is -20°C~50°C. For prolonged battery life, store at 0°C~20°C is recommended.
- To store the battery for a long period, charge the battery for about 20 minutes every five months.
- Before re-use it, it is advisable to fully charge the battery.

#### Caution

- Do not puncture or short-circuit the battery.
- Do not burn the battery pack or immerse it in water.
- Always keep the battery in dry place and stay away from humid.
- Do not attempt to break or dismantle the battery pack.
